The **Stage 2 Report** of the New Zealand government inquiry into the **Havelock North** drinking water outbreak was released in December 2017. The Inquiry Report made 51 recommendations for changes to the management and regulation of drinking water supplies to reduce the likelihood of such outbreaks recurring in the future. The key recommendations are for the treatment of all supplies, setting up of a dedicated drinking water regulator, and establishing a mandatory Licensing and Qualifications systems for Drinking Water Suppliers and Operators. On behalf of the Water Industry Reference Committee (IRC), Australian Industry Standards is the organisation responsible for managing the national **Water Training Package (NWP)** and advises that they are developing a case for change for a review of parts of the NWP Training Package. They are seeking feedback from stakeholders on issues relating to the qualifications and units of competence within Certificate II and III. Comments are sought on any drivers for change (eg new technology) and any specific changes required to the existing qualification rules or units of competence, as well as any new units required.
